

### Graves Mill 1995 Flood, 27-30" of Rain in 24 Hours

The public is invited to attend the observance of the June 27, 1995 Flood. Please join us at Madison County's High School Auditorium at 6 PM on June 27, 2015. Dr. L. Scott Eaton, professor of geology at James Madison University, will speak at 7 p.m. A video presentation of NBC 29 News' coverage of the

event, which President Bill Clinton declared a federal disaster, will be shown.

The New York Times ran an article a week after the event:

> GRAVES MILL, Va., July 1 - When violent thunderstorms hit and swollen creeks flooded central Virginia last week, this small farming

town tucked among the foothills of the Blue Ridge Mountains found itself caught in the middle. Kinsey Run and the Rapidan River broke their banks in the valley below, and boulders and mud slid down from the mountains above. inches of rain in 24 hours. Much of what was in between just washed away.

place in the world,' said Susan Hull, who spent a large part of her childhood the mud out of her family's old plantation house. 'I guess you can still get a sense of that, even though there is this lunar landscape.'

Graves Mill is in northwestern Madison County, one of three Virginia counties declared Federal disaster areas by President Clinton after a week of

> flooding killed at least eight people, forced thousands to evacuate and caused millions of dollars in property damage. State officials said that Madison County was hardest hit, and people in Madison County say that Graves Mill saw some of the worst damage.


> The old Graves Chapel, built in 1885, still stands. So does the town's namesake

Miraculously there was only one 'This was the most beautiful official death in Madison, Doris Frisbie of Criglersville; although Lance Estes suffered a heart attack as he was being airlifted to safety. here and returned today to help clean. He was admitted to the hospital, subsequently released, and passed away 15 days later in his home in Alexandria, VA.
