2011 - A VERY GOOD YEAR FOR LOCAL LAND CONSERVATION

In terms of both numbers of owners and total acreage, 2011 was the second best year for new conservation easements since the Blue Ridge Foothills Conservancy began working with landowners in 1998. Last year 14 landowners in Madison and Greene counties put a total of 1,583 acres under protection.

With the addition of those acres the total acreage under easement in both Counties now stands at 13,406 acres in Madison, representing 7.5% of the County's private land, and 10,098 acres in Greene, representing 12.2% of the private land there.

Also new this past year was having the Virginia Department of Forestry join as a conservation partner in holding easements on four properties in Greene consisting of 385 acres of mostly forested land. They join the Virginia Outdoors Foundation, the Piedmont Environmental Council, and the Land Trust of Virginia in holding easements in our two Counties. Land owners can choose which agency they wish to work with to hold their easements.

Also noteworthy is that 12 of the 14 new landowner properties under easement contribute to one of the 13 Conservation Areas, where from 2 to 20 neighbors have put their land under easement. By preserving areas much larger than a single property, they protect large view sheds, contiguous farmland and forests, lands critical to wildlife habitat and watersheds critical to our drinking water. Being in a Conservation Area also serves to enhance the property values of the Area's landowners because of the local protection afforded against future development.

CONSERVATION FUNDS

Both Madison and Greene Counties now have Conservation Funds. These funds are managed by the PEC with BRFC participation that offers a qualified landowner a no interest loan to pay for the costs of obtaining an easement. The loan is then paid back out of the State tax credit earned by the landowner. BRFC committed \$5,000 to match the funds already raised by members to establish the Greene County Fund.
